REGISTRATION FEES

Registration fee for the PisaMarathon (42,195 km) is (*)

- 60,00 euro + 5,00 for chip rental, from abroad
- **NOTE:** Disregard additional fees for FIDAL, UISP or other federations membership card that are only for Italian national participants. Foreign national runners will only provide a copy of the medical certificate obtained from a doctor in their country. A form that is used for a medical certificate at PisaMarathon can be downloaded from the web site or can be requested from email segreteria@pisamarathon.it

Foreign national participants' medical certificate is used for their insurance coverage. Maximum number of runners for the Marathon (42,195km): 3,000 (*): if you own a Champion-Chip, the code number has to be indicated on the registration form (or on the online form) and no additional fee is requested (free of charge). You will receive a 5,00 € refund when you will return the chip at the end of the race.

Partecipazione

Athletes who have completed their 20th year of age by 21 December 2014 can participate in the marathon (42,195 km). The international marathon is open to all Italian and foreign national athletes registered to sport clubs affiliated to FIDAL federations or corresponding international organizations or who have provided a medical certification for their physical fitness. By completion of their registration athletes attest that they are adequately prepared for various races. The organization will insure that any athlete, having a problem or moments of difficulty during the race, will receive necessary assistance along the course by dedicated personnel and they should also discontinue the race. An athlete, who has not completed his registration by providing required medical certification and/or membership card of his sport association/federation, will be considered a non competitive participant in accordance with the regional regulation and cannot receive any monetary awards. All foreign

national athletes have to forward a copy of their medical certificate, released in their country, or a copy of their local federation membership card. These documents must be received by the 15th of December 2014. However, the maximum number of participants for the marathon is set up to 3,000 and 3,000 participants for the half marathon.

When using an application form for registration, the form must be properly filled and signed, and forwarded via fax to the phone number indicated on the form along with a copy the payment, the medical certificate or the membership card of sport association.

In case the local authorities will impose cancellation of the event due to “force majeure” reasons, the organizer will be released from all responsibilities and liabilities.
